

# 2021 RUTTER'S VIP SUMMER SWEEPSTAKES OFFICIAL RULES

The Rutter's VIP Summer Sweepstakes (the "Game") is offered by CHR Corp. d/b/a Rutter's ("Rutter's" or "Game Sponsor") and is administered by WSP International Limited ("Administrators").

**NO PURCHASE NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

## General Game Information

Approximately 80 Rutter's locations ("Participating Locations") are participating in the Game. The Participating Locations are located in the United States of America ("USA") in the states of Pennsylvania ("PA"), Maryland ("MD") and West Virginia ("WV").

**You must be a registered Rutter's VIP Rewards® member in order to participate and win prizes in the Game.**

If you are not a Rutter's VIP Rewards® member, you can join for free by visiting <https://www.rutters.com/rewards-offers/> and following the instructions to register. There is no purchase or fee required to become a Rutter's VIP Rewards® member. Please allow two (2) days from the day that you register to be a Rutter's VIP Rewards® member to be eligible to participate in the game.

If you have already registered to be a Rutter's VIP Rewards® member, but have not reset your password since we made updates to our Rutter's VIP Rewards® program in March 2020, you must reset your password in order to retain Rutter's VIP Rewards® member benefits and participate in the Game. ## Official Rules

### 1) GAME DATES:

The Game begins at 12:00:01 AM, Eastern Time ("ET") or the start of business on April 26, 2021 (the "Game Start Date"). The Game is scheduled to end in-store at 11:59:59 PM ET or the end of business on August 29, 2021 (the "Scheduled Game End Date") or whenever Digital Ticket supplies are exhausted, whichever occurs first. The period between the Game Start Date and the Scheduled Game End Dates is known as the "Game Period". Certain components of the Game will end on different dates, as indicated elsewhere in these rules.

### 2) WHO CAN PLAY:

To be eligible to participate and win prizes in the Game, you must be:

- A legal resident of the states of PA, MD or WV;
- Over the age of majority in the state in which you reside, as of Game Start Date (the age of majority is 18 years in the applicable states); and
- A registered Rutter's VIP Rewards® member (see General Game Information above for instructions on how to become a VIP Rewards® member for free).

Requests must be received by August 20, 2021. Limit one digital game ticket per request; one request per outer mailing envelope. No mechanically reproduced or computer-generated requests allowed. Your no purchase digital ticket will be emailed to the email address provided. Follow the instructions in the Digital Ticket to reveal your game messages. **All Digital Tickets must be opened by 11:59:59 PM ET on September 6, 2021.**

If you do not receive your Digital ticket via email, you can access via the Game website by logging into your account at [www.rutterssummer.com](http://www.rutterssummer.com), and clicking on “View My Tickets”. To update your email address on your Rutter’s VIP Rewards® membership account go to <https://www.rutters.com/rewards-offers/>, log in to your account and update your email preferences.

Each digital ticket will include one or more ways to win, including: **A) Instant Win, B) Collect to Win, and/or C) Digital Sweepstakes.**

#### **A) INSTANT WIN:**

Select Digital Tickets will contain a message stating “You’ve Won” followed by a description of the prize won (“Instant Win Prize”). Instant Win Prizes are typically products sold in Participating Locations. The approximate retail value of Instant Win Prizes, as of April 14, 2021, range from \$0.99 to \$3.69. See chart below for details. There are a total of 30,660 Instant Prizes available to be won. Individual and overall odds of winning an Instant Prize are noted in the chart below.

**WHAT TO DO WHEN YOU GET A DIGITAL TICKET WITH AN INSTANT WIN PRIZE MESSAGE:** Upon opening a Digital Ticket with an Instant Win message, the Instant Win Prize is automatically applied to the Rutter’s VIP Rewards® account that was used to make a qualifying purchase. **B) COLLECT TO WIN:**

All Digital tickets will contain two (2) Collect to Win Digital Markers (“Markers”). Each Marker is essentially a puzzle piece that forms part of a larger digital picture that depicts a prize. If a participant collects all of the Markers necessary to complete the digital picture, the participant wins the prize depicted in the digital picture. Markers are automatically added to your Digital Collector Card. The Digital Collector Card serves to track which Markers a participant has collected so that he or she knows which Markers he or she has obtained, and which he or she needs, in order to complete the combination and win the prize indicated on the Digital Collector Card.

There are five (5) Collect to Win prizes (“Collect to Win Prizes”) available, therefore, there are five (5) Digital Collector Cards available (see descriptions of each prize below). Each Marker has a corresponding Marker number. Each Marker number will correspond with a space on one of the five (5) Digital Collector Cards. No Marker may be used to win more than one prize. Each Digital Collector Card contains between three (3) and seven (7) common Markers that are produced in approximate equal quantities, and one (1) rare Marker that is required to complete the combination. The rare Marker is produced in smaller quantities (see chart below for odds of receiving any rare marker). If a participant collects all of the Markers (common plus rare markers) necessary to complete a Digital Collector Card, the participant is eligible to win the Prize shown when all Markers are filled on the Digital Collector Card (subject to verification by the Game Sponsor or Administrators).

**Four (4) prizes of FREE Rutter's Gas for a Year**: Prize value is determined by the average retail price of regular gasoline at Rutter's, during the month of the current year in which the winner is selected. Average price per Gallon multiplied by fifteen (15) multiplied by fifty-two (52). Value of prize as of March 31, 2021 is \$2,336.10. This prize is available when a participant **collects all six (6) Markers numbered 9, 10, 11, 12, 13 and 14**. Prize will be automatically applied to the winner's VIP Rewards® account. To redeem this prize, a participant must go to any Participating Location before December 31, 2022. Prize expires after December 31, 2022.

**One (1) prize of \$2,000.00 in Rutter's Gift Cards**, valued at, and limited to, \$2,000.00. This prize is available when a participant **collects all six (6) Markers numbered 15, 16, 17, 18, 19 and 20**. Prize will be awarded as \$2,000.00 in Rutter's Gift Cards of varying denominations totaling but not exceeding, \$2,000.00. Certain conditions may apply (see the gift cards for details).

**Four (4) prizes of FREE Rutter's Coffee for a Year**, valued at, and limited to, \$580.35 each. This prize is available when a participant **collects all four (4) Markers numbered 21, 22, 23 and 24**. Prizes will be automatically applied to the winner's VIP Rewards® account. To redeem this prize, a participant must go to any Participating Location, before December 31, 2022, pick up a Rutter's 16 oz coffee and check out using the Rutter's VIP Rewards® membership associated with the completed Digital Collector Card. Prize value is based on three-hundred and sixty-five (365) Rutter's 16 oz Coffees, each with an approximate retail value of \$1.59. Prize expires after December 31, 2022.

**Four (4) prizes of FREE Rutter's Fountain Beverages for a Year**, valued at, and limited to, \$470.85 each. This prize is available when a participant **collects all four (4) Markers numbered 25, 26, 27, and 28**. Prizes will be automatically applied to the winner's VIP Rewards® account. To redeem this prize, a participant must go to any Participating Location, before December 31, 2022, pick up a Rutter's fountain beverage and check out using the Rutter's VIP Rewards® membership associated with the completed Digital Collector Card. Prize value is based on three-hundred and sixty-five (365) Rutter's Fountain Beverages, each with an approximate retail value of \$1.29. Prize expires after December 31, 2022.

**SECOND CHANCE COLLECT TO WIN PRIZE DRAWING**: ("Second Chance") If any Collect to Win prize is not claimed in the manner provided herein, a random drawing will be held to award the unclaimed prize. All non-winning Digital Sweepstakes Ballots (see Rule 3C below) received through the stated deadline will be eligible for this drawing. If the prize is awarded through the Second Chance drawing, the odds of winning the prize will depend on the number of eligible Digital Sweepstakes Ballots received. **If required, the random Second Chance drawing(s) will be conducted by Game Administrators on or about September 7, 2021.**

**WHAT TO DO WHEN YOU COMPLETE A DIGITAL COLLECTOR CARD**: Once you have collected all of the Markers to complete any Collect to Win combination, click on the "Redeem" button at the bottom of the completed prize category. If all claimed Markers correctly complete the Digital Collector Card, you will be required to complete a Compliance, Release and Indemnity Form ("Release Form") digitally. You **MUST** submit the Release Form for verification before any collect prize is awarded. **Collect to Win online prize claims must be received on or before 11:59:59 PM ET September 6, 2021.**

As a condition of receiving any Collect to Win or Second Chance prize, the winner must sign and return, within seven (7) days of receipt, the Release Form under which, among other matters, the winner confirms his/her compliance and eligibility with these Official Rules, provides proof of identity and releases and indemnifies Game Sponsor, Administrator and other certain parties.

**COLLECT TO WIN PRIZES AND ODDS**: The Odds of winning a Collect to Win Prize vary depending on the number of Digital Tickets a participant obtains. For Collect to Win Prizes, odds reflect a participant's chance of obtaining the rare Marker for each prize category, as shown below in Table 2.

**C) DIGITAL ONLINE SWEEPSTAKES:**

There are two (2) ways to earn ballot entries (“Ballots”) for chances to win prizes in our Digital Online Sweepstakes.

- 1) **By entering Bonus Codes** that are included on our social media posts and advertising. Throughout the Contest Period, Game Sponsor may offer Bonus Codes on certain social media or advertising platforms including but not limited to Facebook and Instagram. Game Sponsor will post a Bonus Code, along with additional instructions, on their social media pages that customers can then enter at [www.rutterssummer.com](http://www.rutterssummer.com). Customers must view the social media post for full details and instructions. Customers will receive one (1) Bonus Entry per valid Bonus Code entered. Bonus Codes can only be entered once. All Bonus Entries are valid for the Bonus Code Sweepstakes Prizes only (see chart below). The Digital Game is in no way sponsored, endorsed, administered by, or associated with Facebook or Instagram or any other social media platforms
- 2) **By receiving a Digital Ticket** containing a message stating that a participant has received two (2), three (3), five (5), ten (10) or twenty-five (25) ballot entries (“Ballots”) for a chance to win in our Weekly Digital Sweepstakes. Odds for the denomination of Ballots received are listed below.

There will be a total of twenty (20) Digital Sweepstakes Drawings to award a total of twenty (20) prizes (see chart below for schedule of drawings and prizes to be won). All winners will be randomly selected per drawing from among all non-winning, eligible Ballots received prior to each drawing. All non-winning Ballots will automatically rollover into subsequent drawings. Odds of winning any Digital Sweepstakes prize depends on the number of eligible Ballots received prior to each drawing. Prizes are nontransferable and have no cash substitution, in part or in whole. All online drawings will take place by the Game Administrators, at their offices, on the dates specified in the chart below.

#### ADDITIONAL PRIZE DETAILS:

**Weekly \$100.00 Rutter's Gift Card:** Prize will be awarded as a \$100.00 Rutter's Gift Card. See gift card for details. One (1) prize per person, per household, however winner can be eligible and also win in the Bonus Code drawings, provided an eligible Bonus Code is entered.

**Bonus Code \$1,000.00 Rutter's Gift Card:** Prize will be awarded as a \$1,000.00 Rutter's Gift Card. See gift card for details. One (1) prize per person, per household, however winner can be eligible and also win in the Weekly Gift Card drawings, provided eligible Digital Sweepstakes ballots have been entered.

**WEEKLY DIGITAL SWEEPSTAKES ODDS:** The odds for the denomination of Digital Sweepstakes Ballots received for Weekly Prize Drawings are shown below in Table 4; however, the odds of winning any Digital Sweepstakes drawing prize (including \$100.00 Weekly Gift Card Prizes, Bonus Code \$1,000.00 Gift Card Prizes and if required, any Second Chance Collect to Win Prize Drawings – see Rule 3B above), depend on the number of eligible Ballots received in accordance with these Official Rules prior to each drawing.

#### **4) NOTIFICATION AND REDEMPTION:**

**NOTIFICATION:** If you have been selected as a potential winner in Collect to Win, Second Chance or Digital Sweepstakes, or if you have submitted a verified Collect to Win prize claim, the Game Sponsor or Administrators will attempt to notify you via email, postal mail, registered mail, courier and/or phone. A minimum of three (3) attempts will be made to contact any winner. If the winner does not respond within seven (7) days after the third unsuccessful contact attempt, the prize will be deemed forfeited and the Game Sponsor will hold a drawing to select an alternate prize winner from among the pool of remaining, eligible entries received. If the alternate prize winner does not respond within seven (7) days of the third unsuccessful contact attempt, the prize will be forfeited.

**REDEMPTION:** Once verified and unless specified otherwise, prizes will be shipped by prepaid delivery to the Participating Location closest to winner's valid disclosed address. Allow approximately four (4) to six (6) weeks for shipment of prizes to Participating Locations following verification. A minimum of three (3) attempts will be made to contact any winner to arrange for pick-up of any prize. Prizes that are not claimed within thirty (30) days of the third attempt to be contacted will be deemed forfeited and the Game Sponsor will hold a drawing to select an alternate prize winner from among the pool of remaining, eligible entries received.
